Self-Introductions and Anti-Trust Reminder

PENNDOT Topics by Joseph A. Bracken III, P.E., CWI

- Manhole standards PennDOT has received comments and due to other priorities a response won't be forthcoming until March 2016.
- ASR Phase 2 is in the works.
- Now that winter weather is here be aware of cold temperature concrete practices.
- P3 is moving forward. In full operation for prestressed beams gearing up for box culverts
- P3 projects have 106 box culverts in 2016. Lettings started in September, 2015 and will continue every month through the Spring, 2016. In addition to P3, PennDOT has 100+ box culvert projects hitting the street. They are asking fabricators to attend a meeting to discuss schedules, backlogs, etc. Looking for ideas as to how to expedite the process.
- Looking back over last 5 years typically 170 box culverts/year. Should be more than 200 next year.
- Joe is gathering information from districts as to the location/county/dates/span/skews to provide industry with a complete picture of upcoming work.
- They want to take advantage of the slow time in winter. Also want to review repair procedures in advance to expedite these projects. Refer to Pub 145 for typical repairs.
- Box culvert meeting for precasters is Thursday November 12th at PennDOT lab. Contact MS for more information.
- Box culvert E-notification was released. They are still reviewing sizes, lift capacity, transportation limitations, etc. Once this information is compiled they will include in Bulletin 15 so that GC's are not wasting time looking for fabricators. Please review the draft E-notification and forward any corrections to JB or MS.
- Discussion regarding whether culvert sections could be stamped further in advance of shipping.
 Continued discussion at meeting on 12th.
- Aesthetic coatings no updates.

Quality Assurance and Specification Issues

- LRFD Manhole Standard Exceptions PPA website has manhole exception portal. The login/password from 2010 is still valid. Contact MS if you need access.
- PADOT would like to hear ideas for improvements of precast box culverts. Discussion as to whether to dry-fit at the plant? Issues with culverts not fitting together in the field.
- Best practice is to dry-fit to make sure they fit together. Not necessary on every piece, but commonplace if there may be an issue with complexity. Some precasters fit the first two pieces together if no issue then proceed with casting remainder. If there are 2 molds, they will cross fit to make sure no issues. On long culverts sometimes pieces are checked just to make sure nothing has changed. It is unreasonable to dry fit every piece.
- Discussion regarding box culvert schedules production capacity is often based on only 50% of the year because projects are not awarded in time. Not enough capacity to meet compressed schedule. Lead times are a dynamic thing if nothing to bid on can turn around fast, but when 100 are let at a time it causes an issue. Other factors include the complexity of job-- w/ skew angles, double skews ... if they could square them off It would save a lot of time and headaches.
- Currently, nothing to bid on. Ones being let now are not being produced until Feb or March.
- We are seeing a lot of P3 jobs that are not fully designed. Asked to bid from TS&L drawings then throwing a number real design comes out and the numbers aren't even close. Changes are being made after shop drawings are complete. Issues to be discussed at the box culvert meeting.

• District 5 HOP projects –can certification be used instead of inspection? PennDOT to follow up on this issue. To be discussed at next meeting.

Action Items since September 2nd 2015

- Discussion as to whether PPA precasters need NDA. More GCs & utilities require nondisclosure agreement to review drawings – do we need to protect our proprietary information?
- Consultants are very intimate with our plant. They don't have anything in terms of an agreement we should have something for them.
- Consultants added that although nothing is signed, they are trained to make sure we do not share those things.
- Is it okay for people to take pictures and how do we keep them from sharing info?
- Supervisors not always in plant inspectors take pictures that are then used to train people in the future. Consultants are trained not to interfere with plant procedures, but simply communicate with QC managers. Just there to enforce PADOT specification.
- Would be beneficial for binding obligation instead of just "best practice"
- Typically don't share confidential info. But how do you know that you are protecting that information to the best of your ability? Will an inspector actually sign NDA?
- Put general provision in the front of 145 for inspectors (simple statement/language) so inspectors don't need to sign anything.
- Topic tabled for further discussion at the next meeting.
