# Buy America Act - Bob Horwhat, PE, Chief Materials Engineer, PennDOT

- Discussion regarding Buy America Act and PA Steel Procurement Act
- See attached for more information regarding the history and specifics of this legislation
- If steel is unidentifiable on its face must certify with mill cert (see memorandum 12-21-15)
- Clarification "steel" is predominately steel (90%)
- Bolts, nuts, screws, tie wire, spacers, chairs, lifters are no longer exempt
- Products that are permanently installed must be domestic
- Pass on mill certs if MMUSA
- PennDOT projects let after 2/18/16 all materials must be domestic
- NPCA has met with FHWA requesting that they reinstitute the 2012 memorandum
- For federally funded projects- greater of 0.1% of (total) contract value or \$2500 is allowance for foreign steel for that project
- Requires full disclosure, including costs of foreign steel (invoices)
- Submit accounting of foreign steel in bid prior to project award to document any foreign steel used in precast
- Use of foreign steel act- PennDOT: 75/25 rule
- If a product contains both domestic and foreign steel it is considered US steel if at least 75% of the cost of the articles, materials and supplies are domestic. Must provide invoices/costs to contractor.
- Documentation is required by both laws
- Packing slip not required if requests are inconsistent across the districts –inform Bob Horwhat. Invoicing must be accurate and current – correlating to the material within the precast products.
- The appeal process in in the works but it could take 6-18 months.
- Lifters to be identified on drawings.
- Mill certs have not been required in the past for incidentals, but will be required soon
- PennDOT is trying to avoid collecting mill certs and have the precast hold them
- Web site will be set up to post FAQ for Dept. and business partners with links to FHWA, etc.
- Be aware that FHWA will not issue waivers. Requests for waivers are being accepted but put on hold so no decisions will be made in the near future.
- ECMS will list funding sources so you can determine if it is federally funded or other.

\*\*\* As a follow up to our meeting – Bob emailed me to add this to the minutes regarding any precast inventory that you might currently have:

--- a subject I hadn't considered was raised today concerning 'stock' precast items. I reached out to our FHWA PA Division office and they indicated that the production date was irrelevant. If there is foreign steel in the stock items and they are shipped to Dept. projects let after February 18, 2016 then the new rules apply, ie incidental foreign steel incorporated into the items must be disclosed and accounted for. \*\*\*

# PENNDOT Topics by Joseph A. Bracken III, P.E., CWI

- The new ASR Spec is still being written/approved. PennDOT will host webinar and possibly attend future PPA meeting to review changes
- Manhole standards- being reviewed by FHWA, something should be available soon.
- Stock items being shipped to projects other than PennDOT projects may require approval from PennDOT prior to shipping. Additional storage fee not applicable. Storage of more than 45 days you can bill for product. Stock items 50% of production can be in stock.
- For those aggregate suppliers are sending different aggregates Bulleting 14 properties must be met suppliers must send new data to PennDOT. It is OK to use mix designs with higher strengths- send design history to Serge for old mixes with higher strengths.
